

General Terms & Conditions

For 2024 Residential Products Promotion Programme

The 2024 Residential Products Promotion Programme (the "**Programme**") is operated by Huawei Technologies (UK) Co., Ltd. ("**Huawei**"), whose registered office is at Earley East, Thames Valley Park Drive, Reading, England, RG6 1PT. By taking part in the Programme, you agree to be bound by the following terms and conditions.

1. The Promotion

- 1.1. The Programme is open to all installers of the United Kingdom (excluding Northern Ireland).
- 1.2. Subject to terms and conditions herein, installers shall be eligible to claim:
 - a) £200 rebate* for a new installation of 4-6KTL-L1 inverter together with DC/DC Module and Luna 5kWh battery; or
 - b) £250 rebate for a new installation of 4-6KTL-L1 inverter together with DC/DC Module and Luna 10kWh battery (2 x Luna 5kWh batteries); or
 - c) £60 rebate for a new installation of 4-6KTL-L1 inverter only.
- 1.3. The rebate will be issued by SKE Engineering Limited, whose registered office is at Cubix Noble House, Capital Drive, Linford Wood, Milton Keynes, United Kingdom, MK14 6QP ("SKE") on behalf of Huawei.
- *The rebate values above are excluding VAT.

2. Promotion Period

The Programme will run from 00:01 on 15 April 2024 (GMT) to 23:59 on 15 July 2024 (the "**Promotion Period**"). Rebate applications must be received by SKE between 1 May 2024 to 15 August 2024 (the "**Rebate Claim Period**"). Any application received outside this period will not be accepted.

3. Promotion Rules

- 3.1. The promotion only applies to Huawei products specified in the Eligible Product List (as set forth in clause 6).
- 3.2. Eligible products must be purchased from a Participating Partner (as set forth in clause 7) in the United Kingdom (excluding Northern Ireland). The products purchased from other suppliers or in other jurisdictions will not be counted.
- 3.3. Eligible products must be installed and connected and/or verified successfully to Huawei's FusionSolar Smart PV Management System within the Promotion Period.
- 3.4. You will need to create a new account and register the installed products on the Huawei Smart PV Community website.
- 3.5. The promotion is subject to availability and while stocks last.
- 3.6. An eligible product can only be counted once. When the rebate is claimed under this Programme, it cannot be claimed again under other similar schemes or programmes.

4. Claiming the rebate

- 4.1. To claim a rebate, you must submit an application to SKE by email at uk@ske-solar.com with the following information within the Rebate Claim Period:
 - a. company name, email address and phone number;
 - b. FusionSolar Account Name, PV Plant Name, Installation Date;
 - c. Huawei Smart PV Community account name;
 - d. products type (e.g. 5KTL Inverter, Luna 5kWh Battery) with serial numbers (SN numbers); and
 - e. any other relevant information requested by SKE.
- 4.2. SKE will notify you the result of your application on behalf of Huawei within 21 working days and this decision is final.

5. Issue of rebate

5.1. If your rebate application is approved, you will be required to send a valid invoice for an approved claim amount to SKE within 7 working days after you receive the notification.

- 5.2. The invoice must correspond to the template provided by SKE.
- 5.3. SKE will make a bank transfer to your bank account within 30 days after receiving your valid invoice.
